SCFPD Accepts SAFER Grant, Hiring Four Firefighter/Paramedics from FCTC Statewide Eligibility List

Riverbank, CA – The Stanislaus Consolidated Fire Protection District Board of Directors, Oakdale City Council, and Oakdale Rural Fire Protection District Board of Directors have approved acceptance of a \$477,123 Staffing for Adequate Fire and Emergency Response (SAFER) Grant from the Department of Homeland Security to improve local fire department staffing and deployment capabilities so they may more effectively and safely respond to emergencies. This grant will fund three firefighter positions for a period of two years, at the end of which, SCFPD may have the opportunity to apply for an additional two years of funding. At the end of the grant performance period, all three organizations plan to evaluate the possibility of retaining the positions, which they are hoping to do. The District is recruiting for a fourth firefighter position to fill an existing vacancy.

Since 63% of the call volume in the area served by SCFPD are medical in nature, the District, whose current engine companies provide basic life support care for patients, is implementing a paramedic program to begin providing advanced life support care for our community. This will necessitate recruitment of Firefighter/Paramedics, a new position, which the District plans to do via the Firefighter Candidate Testing Center (FCTC) Statewide Eligibility List. If you or anyone you know meets the <u>qualifications</u> for the position of Firefighter/Paramedic with SCFPD, are interested in joining the SCFPD family and are not already active on the FCTC Eligibility List, please visit <u>https://www.fctconline.org</u> to register and get more information about upcoming testing. Interviews will be scheduled for late September and only candidates actively on the FCTC Statewide Eligibility List will be considered.

FIREFIGHTER/PARAMEDIC

JOB DESCRIPTION

Employees within the Firefighter/Paramedic job classification operate as a member of a fire company to respond to fire, rescue, hazardous material, medical and other emergencies to protect life and property from the effects or potential effects of emergency conditions. Employees in this classification also administer advanced life support, respond to non-emergency events and participate in training, equipment and station maintenance, fire prevention and public education activities.

SUPERVISION RECEIVED AND EXERCISED

Employees in the Firefighter/Paramedic classification are supervised by a Captain, Acting Captain or higher ranking officer. Employees within the Firefighter classification do not supervise other employees.

EXAMPLES OF DUTIES

Duties may include, but are not limited to the following, which are listed in no particular order or significance:

- Respond to fire emergencies as part of an assigned company; lay and connect hose; operate nozzles and direct water streams; raise and climb ladders.
- Operate all types of portable emergency equipment including; fire extinguishers, pike poles, hand lines, smoke ejectors, salvage covers, forcible entry tools, breathing apparatus; emergency medical equipment and other rescue equipment.
- Analyze and initiate advanced life support care to the sick and injured
- Respond to hazardous materials incidents and function within certified level of training
- Participate in fire inspection and other fire prevention and public education activities; ensure that businesses are operating in compliance with the fire code; maintain appropriate records and files.
- Participate in public education activities including facility tours, career days,

- Attend training sessions which include firefighting techniques, hazardous material response, emergency medical care, proper use of all equipment and related tools, strategy and tactics, policies and procedures and other didactic and manipulative training activities.
- Clean apparatus and equipment and perform general custodial duties as required.
- Assist in maintaining pre-fire plans; update maps as required.
- Respond to public complaints regarding weed abatement and fire and life safety hazards.
- Perform related duties as assigned.

WORKING CONDITIONS

Environmental Conditions

Emergency response environment; exposure to hot and humid work environment making rapid transitions from rest to near maximal exertions without warm-up period.

Physical Conditions

Essential and marginal functions will require maintaining physical condition necessary for bodily mobility to operate and crawl in restricted space; work, stand, or sit for prolonged periods of time; operate motorized equipment and vehicles; and the ability to work in hot and humid environments while wearing firefighting equipment which may inhibit all necessary senses.

MINIMUM QUALIFICATIONS

Age:

21 years of age at time of appointment.

Abilities and Knowledge

Ability to:

- Understand and act in accordance with District policies, rules, and instructions.
- Learn to apply firefighting and medical techniques and procedures
- Demonstrate mechanical aptitude as required in the operation of firefighting equipment.
- Perform emergency medical practices and procedures at the level of a competent

- Retain operational awareness in emergency situations.
- Think and act quickly and effectively in emergencies.
- Understand and follow oral and written directions promptly and accurately.
- Perform occasional heavy lifting up to 100 lbs. and physical maneuvering.
- Perform general office and clerical duties in support of assigned activities.
- Operate a computer and learn how to use general and job specific computer applications
- Communicate effectively, both orally and in writing.
- Establish and maintain cooperative working relationships with coworkers and members of other public agencies.
- Work in communal environment that includes common sleeping, eating, and restroom facilities.
- Analyze fire and emergency conditions and employ effective courses of action.
- Maintain and test fire sprinkler systems and fire hydrants.
- Operate and maintain voice radio equipment.
- Rescue and evacuate victims from buildings, vehicles and other entrapments.
- Pass required oral, manipulative, and written exams.
- Obtain and maintain Paramedic Accreditation in Stanislaus County
- Qualify to act as an Engineer within three years of appointment.
- Ability to obtain Firefighter II certification within two years of appointment.

Knowledge of:

- Principles, practices and procedures of modern firefighting.
- Fire apparatus, equipment, tools, devices, facilities and their proper use.
- Basic principles of hydraulics relating to fire equipment.
- Safe driving practices.
- Basic life support emergency medical principles and practices

Experience:

Six months full-time, paid firefighting experience

or

One year as an active reserve, volunteer or intern firefighter

or

Equivalent combination of full-time and volunteer experience
